ANACONDA LEADERSHIP ACADEMY COMMITMENT CONTRACT

Anaconda Leadership Academy is part of a unique partnership between students, parents/guardians, school staff, community volunteers and high school officials. It is critical that all parties involved share responsibility and work together as a whole to ensure the student's success in the program. Please read the following commitments carefully, as your signature below will indicate you are in full support of the program.

Student Commitment – I agree to:

1. Attend high school (scheduled classes, labs, and discussions) regularly.
2. Attend check-ins with my Leadership Academy coach.
3. Be academically responsible, make sure to ask for work prior to missing class for Leadership Academy. Each month I will need approval from each of my teachers in order to attend that month's workshop.
4. Display behavior and attitudes that are respectful, appropriate, and bring credit to my parents, my school, the Anaconda Leadership Academy program, and myself.
5. Agree to follow the Anaconda Junior/Senior High School code of conduct policies as outlined in the student handbook.

Students who neglect their responsibilities to Anaconda Leadership Academy Program by failing to comply with conditions listed above may be dismissed from the program.

Parent/Guardian Commitment – I agree to:

1. Grant permission for my child to participate in the Anaconda Leadership Academy program.
2. Fully support and facilitate my child's involvement in the Anaconda Leadership Academy program.

Anaconda Leadership Academy Staff commitment – We agree to:

1. Meet with each student on a monthly basis for workshops, to provide information and activities that will help him/her to achieve his/her full potential.
2. Notify students on dates and times for workshops in a timely manner.
3. Ensure that the time spent at the Academy is productive and enriching.
4. Work closely with parents/guardians and school personnel to ensure each student is receiving the best combination of services.

Academic Probation and Dismissal Policy:

Reasons for probation may include the following:

1. More than two absences from Anaconda Leadership Academy workshop days.
2. A student shows a lack of initiative in completing assignments or responsibilities (at school or Leadership Academy)
3. A student demonstrates disruptive behavior with peers or staff.
4. A student does not adhere to the business casual dress code.
5. A student does not complete the required community service hours at the end of the program year.
